The Mali Enterprising Leaders (MEL) Programme is a capacity support and development programme targeted to the needs of micro and small Black, Asian and minority ethnic (BAME) led voluntary



The overarching programme brings together...

1. The Greater London Authority/City Bridge Trust Civil Society Roots Fund programme (April 2020 – 31 March 2021); and
2. The National Community Lottery Fund's Covid-19 Emergency programme: Capacity support and development (Sept 2020 – 31 March 2021).

Aim

The aim is to enhance and raise the voice of BAME led community and voluntary organisations through the building of confidence, knowledge, capacity and capabilities, including networking opportunities.



Overview of the capacity support and development programme...

1. **Roots programme** (n=12) on London's BAME led organisations with community asset and BAME infrastructure support organisations;
2. **National capacity support and development** programme across the regions of England with focus on micro and small organisations (n=50).
3. The programme consists broadly of:
 - Series of webinars
 - Organisational capacity assessment
 - 1:2:1 support (one to 2 days)
4. Criteria for support and the Application process
 - Roots aspect is already working with 12 organisations and so that will continue (community asset and infrastructure organisation support)
 - National support and development programme (<https://www.ubele.org/mel-england>)
5. Timescale: by end March 2021

Good Value for Money

You need to show funders that your project is good value for money by:

- Comparing quotes/checking prices
- Working out your unit costs
- Maximise use of resources such as space and equipment
- Sharing back office functions
- Recycling and environmentally friendly approaches
- Organisations can introduce a range of efficiency measures



What are core costs?

It is important to consider how to cover core cost of an organisation when fundraising:

- **Income generation** - costs of fundraising, monitoring and evaluation
- **Support Services** - costs related to finance and administrative staff, management, premises and equipment (eg. rent/lease payments, heat, light, utilities, water rates, insurance (essential building/contents insurance, public liability, pro-rata)
- **Governance, representation and user engagement** - costs involved in service user involvement and developing and engaging a trustee board
- **Innovation and quality** - costs involved in exploring and developing new approaches



Voice4Change

- Voice4Change England is delighted to announce that Round 2 of applications for our grants programme will open at **1PM today 25 November**.

The fund is for **Black, Asian and Minority Ethnic (BAME)** community groups and organisations, working to deliver COVID-19 services in England and helping to tackle the disproportionate impact of COVID-19 on BAME communities.

- There are three possible sections to apply within: delivering COVID-19 services, mental health services and sports activities to tackle BAME inequalities.
- All grant awards will be in the region of £5,000 to £10,000.
- The deadline for applications is Friday, 4 December at 5PM.

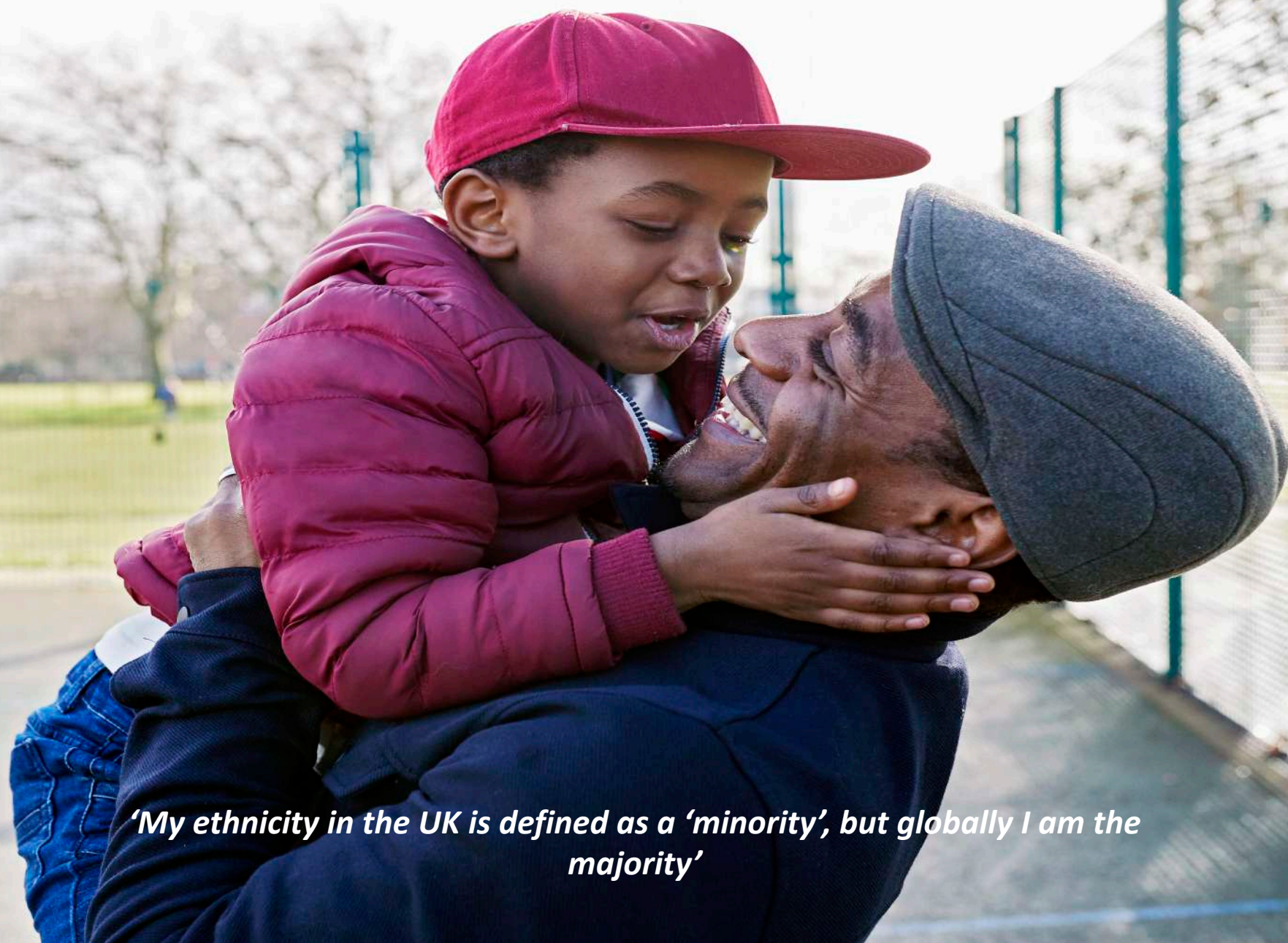

The Global Majority Fund

Purpose:

To provide emergency Covid-19 support to organisations working with *Communities Experiencing Racial Inequality* across the UK

- ‘Communities experiencing racial inequality?’
 - who is this? Why now?
- What am I applying to do?
- Funding available: £150K - £250K
- Deadline: 30 November 2020 @ Midday
- Why work through intermediaries? Why not give direct?
- What can the funds be used for?

Eligibility



ELIGIBILITY CRITERIA FOR INTERMEDIARY TECHNICAL PARTNERS

- The funding is for distribution in the United Kingdom only.
- You need to be a legally constituted group or organisation to apply for funding.
- Your organisation must have an annual income of at least £75,000
- Your organisation must be **led** and **managed by the communities** you serve – by this we mean at least 51% of the senior management team and trustees are from the community(ies) you represent.
- Your organisation should have experience of grant making.
- We are not expecting you to work with everyone!
- Presence and/or networks as a minimum, at a [county level](#) to onward grant to.
- Partnership bids welcome
